

# The Chapels Royal of St Peter ad Vincula and St John the Evangelist HM Tower of London

Dear friends,



This coming Sunday, 9th November, is Remembrance Sunday. We shall begin our traditional service outside on Tower Green at **1050** and hope that as many of you as possible will join us for this important tribute to those who have given their lives for our freedom. Please note the earlier start time, which enables us to be ready for the two minutes' silence at 1100. The first two minutes' silence in the UK was held on 11<sup>th</sup> November 1919, the first anniversary of the Armistice. The initial idea came from South Africa and was submitted to King George V. He made an announcement on 7<sup>th</sup> November, published in all the newspapers, requesting a brief suspension of all activities four days later.

At 1100 on 11<sup>th</sup> November 1919, the country duly fell silent. Traffic stopped and even trains rolled to a halt. In a Nottingham court, a murder case stopped, and everyone present stood in silence for two minutes. Some of us can still remember road traffic stopping at 1100, people halting their shopping or simply standing still in the street in respect. Such informal public observance seems to have declined, which only reinforces the importance of formal Remembrance events such as ours.

In addition to being an important way of reminding people of the sacrifices made for our continued safety, the annual Remembrance is the major occasion for fundraising by the Royal British Legion (RBL) through their sale of poppies and other charitable collections. The RBL does vital work in supporting those members of the Armed Forces and their families who suffer as a result of their service, whether their injuries are visible or invisible. Donations made to the RBL <u>online</u> attract Gift Aid, thereby increasing their value by 25%.

Do show your solidarity this Remembrance Sunday with the men and women of the Armed Forces. With all good wishes, Cortland.

#### **Poems for Remembrance Sunday**

This week we have two poems to think about both from the First World War. First, we have the famous lines written by the Canadian Lieutenant-Colonel John McCrae, often recited during Remembrance events: In Flanders Fields. Next, we have The Soldier by Rupert Brooke. When I was at school, we studied these two pieces as 'war poems', together with those by Wilfred Owen, Robert Graves, Siegfried Sassoon and others. Both McCrae and Brooke died during the conflict. The content of McCrae's poem is overtly related to war, in a particular time and place, as the writer takes on the persona of those who are already dead, buried in the mud of Flanders and over whose bodies the poppies grow. It encourages readers to carry on the fight, not only in pursuit of a just cause but also in order that the sacrifice of others should not have been in vain; not to continue the fight would be a betrayal of the dead. Remember that McCrae was a senior officer and an experienced soldier. Rupert Brooke, on the other hand, joined up only at the outbreak of war. A civilian and a classicist who had been awarded a fellowship at King's College, Cambridge in 1913, he was already a published poet. His nostalgic poem The Old Vicarage, **Grantchester** had been written from Germany in 1912 when he was experiencing intense homesickness. Whilst his verse here is entitled *The Soldier*, there is in fact little in its content to mark it as a 'war poem' and its sentiments perhaps have more in common with his 1912 piece. That said, it was Brooke himself who gave the poem its title – and its alternative title *Nineteen-Fourteen: The Soldier*. So, it seems certain that Brooke himself did want his readers to see it as reflecting not only homesickness in general but that of a soldier on active service overseas, facing the possibility of death.

Thus, we have two war-related poems, one of martial defiance and one of wistful nostalgia. Both provide food for thought at this time of Remembrance.

#### In Flanders Fields

In Flanders fields the poppies blow Between the crosses, row on row, That mark our place; and in the sky The larks, still bravely singing, fly Scarce heard amid the guns below.

We are the Dead. Short days ago
We lived, felt dawn, saw sunset glow,
Loved and were loved, and now we lie,
In Flanders fields.

Take up our quarrel with the foe:

To you from failing hands we throw

The torch; be yours to hold it high.

If ye break faith with us who die

We shall not sleep, though poppies grow

In Flanders fields.
